Customer Contract

I, the undersigned, understand and agree that the deposit of \$200 will be refundable for any reason before the baby is 28 days old. After such time any deposits are non-refundable. If for some reason a baby that has had a deposit put down on it does not survive to weaning, I will then be given the option of transferring my deposit to another available or future baby or a full refund will be issued within 10 days. I also agree to pay the remaining \$300 at the time that I am informed the baby is weaned and ready to come home. ALL monies owed to Sassicat Aviary will be paid in FULL before I take delivery of my baby.

I, further understand that all sales are final and no refunds will be given. The SELLER does not assume any responsibilities for this pet after leaving the premises for veterinarian or medical expense, landlords disapproval, allergy to animals, disagreement of family, behavioral situations, or for any other reason. It is further understood and agreed that no warranty or representation has been made with respect to the bird purchased except as set forth in writing in this agreement.

I understand that if I want a specific sex, I will pay for the sexing of all babies in the clutch, and that sexing costs are not refundable even if none of the babies are the sex I want. I then will have the option of taking one of the current babies, or transferring my deposit to a future baby. If I transfer my deposit for a future baby—I agree that again I will need to pay for the sexing of the entire clutch. The SELLER will refund any sexing fees only if another customer requests to know the sex of the baby and they pay for the sexing on a baby that has already been sexed.

If I don't care for a particular sex, but want to know what my baby is then I will pay \$25 for the sexing of this one baby, and I will receive a certificate of the results for this baby.

If a baby is not DNA sexed - the SELLER can make a fairly accurate guess, the SELLER does not guarantee such guesses.

If Sassicat Aviary is contacted in reference to the band number of this bird, SELLER is hereby given permission to share my name and contact information for the purpose of retrieval of the bird should it have been lost. If for any reason we are no longer able to care for this bird and we transfer ownership we will give notice to SELLER to update their records as to the ownership of this bird.

I have opted to have my baby shipped to me by the airlines. I understand that SELLER will make every effort to find the least expensive and most direct route for my baby to travel. In the event that one airline does not have a direct route, the SELLER may check other airlines even if they cost more. I understand that the shipping cost are contingent on the airline charges, and SELLER is not liable for any claims made as to exact costs associated with the shipping. I agree to pay all costs to SELLER before shipment of my baby, including but not limited to airline shipping cost, health certificate cost, and crate cost. I also understand that shipping can be very stressful on a baby and I acknowledge that SELLER has no control over the conditions the bird may encounter during shipping. I further understand that stress due to shipping could cause minor health issues, or regression (seeming to be unweaned), the SELLER is not responsible for such issues.
